2023 Annual Meeting and Election of Directors

March 29, 2023 at 5:30 pm at our Davis Drive Headquarters 384 Davis Drive, Morrisville, NC

By this notice, the members of RTP Credit Union are being publicly and individually notified of board vacancies, which will occur at the end of the current term. The positions being elected are three board positions, whose current terms expire in March 2023. The nominating committee has selected the following two individuals as candidates for the 2023 election. One position is still open.

Other members may petition for candidacy for the Board of Directors by producing the required number of signatures - 1% of membership, a statement of agreement to run for office and an agreement to serve if elected. The petition is due to be returned to RTP Credit Union no later than 5:00 pm Monday, February 6, 2023. If no other candidates are submitted, the vote will take place at the annual meeting by a show of hands. Should there be more candidates than open positions, the vote will take place at the annual meeting and will be by ballot.
